Supply & Fixing Racks for Medical Record Room and Main Record Room at District General Hospital - Matara

1. **The Chairman, Regional Procurement Committee (Zone 06)**, on behalf of the **Department of Buildings** now invites sealed bids from eligible and qualified bidders for “**Supply & Fixing Racks for Medical Record Room and Main Record Room at District General Hospital - Matara**” as described below and estimated to cost **Rs. 4.15 million**.

The construction period is **91 Days**.

2. Bidding will be conducted through National Competitive Bidding Procedure (NCB)
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall be registered in the field of building construction for Grade **C8 or above** with the Construction Industry Development Authority (CIDA), valid until the date of closing of the bids. Further the registration should be valid at the date of award.
4. Interested bidders may obtain further information from the **Chief Engineer (Zone 06), Department of Buildings, No. 10, Upper Dickson Road, Galle** and inspect the Bidding Documents at the same address on any working day from **9:00hrs to 16:00 hrs**.

A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written application to the Chief Engineer (Zone 06), Department of Buildings, No. 10, Upper Dickson Road, Galle from **29.04.2026** until **14.05.2026** from 9:00hrs to 15:00 hrs upon payment of a non refundable fee of Rupees one thousand five hundred (Rs. 1,500/-).

Bids shall be delivered or sent by registered post to the **Chairman, Regional Procurement Committee (Zone 06), Chief Engineer’s Office (Zone 06), Department of Buildings, No. 10, Upper Dickson Road, Galle** to reach on or before **10:00 hrs** on **15.05.2026** Late bid will be rejected. Bids will be opened soon after closing at the same address presence of the bidders’ representatives who choose to attend.
7. Bids shall be Valid for a period of **49** Days from the date fixed for receiving of Bids or any extended period.
8. All Bids shall be accompanied by a Bid Security which shall be;
 - in the form included in the Section 09 in the Bidding document.

 - for a amount of **Rs. 62,500.00**
